8. Any Other Business

The following comments were taken from the floor :-

- **Mark Ellis** – The club will be piloting the Superteams competition format in partnership with England Athletics. Superteams is a format based on tracking improvement in athlete pb's for U9, U11 & U13 athletes across 3 or 4 in club competitions. A funding bid for equipment to hold the competitions and for officials equipment has been submitted to England Athletics, but we may not know the result until late April and we could do with the equipment before then. It was agreed that the equipment would be bought in advance so that we have the equipment and the EA grant could still be paid if we're successful (and as EA suggested we made a bit, we're very confident). Mark reported that he'd had discussions with England Athletics and Polytan on the cost of building a tartan track and the pricing would be shared when it was received. Polytan have developed a cheaper conversion for cinder tracks to be upgraded without needing new foundations to be dug, which provides a big saving.
